ARTICLES OF INCORPORATION

OF

INTERNATIONAL BIRD RESCUE

RESEARCH CENTER

I

The name of this corporation shall be: INTERNATIONAL BIRD RESCUE RESEARCH CENTER.

II

The purposes for which the corporation is formed are:

- a) The specific and primary purposes of the corporation are to secure, catalogue and distribute scientific and educational data and information relacing to the capture, cleaning, care and rehabilitation of wildlife, particularly wild birds, which have been injured through natural or man-made pollution or destruction of their natural environment, to make such information available on a regular as well as an instant emergency basis to interested citizens, educational institutions, scientists and public and private organizations, to provide regular employment and training to one or more emergency disaster teams, and to provide training in emergency care and treatment of wild birds for interested individuals and staff members of other agencies and organizations.
- b) The general powers and purposes of the corporation are to engage in any lawful activity within the scope of Section 501(c)(3) of the Internal Revenue Code and Sections 214 and 23701d of the California Revenue and Taxation Code.

Restriction of right to amend articles

This corporation is organized pursuant to the General Nonprofit Corporation Law of the State of California.

IV

The county in this State where the principal office for the transaction of the business of this corporation is located is Alameda County.

This corporation is not organized, nor shall it be operated, for pecuniary gain or profit, and it does not contemplate the distribution of gains, profit or dividends to the members thereof and is organized solely for nonprofit purposes. The property, assets, profits and net income of this corporation are irrevocably dedicated to educational, religious, charitable, literary, and/or scientific purposes and no part of the profits or net income of this corporation shall ever inure to the benefit of any director, officer or member thereof, or to the benefit of any

private persons. Upon the dissolution or winding up of this corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for educational, religious, charitable, literary and/or scientific purposes, and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code and Section 23701d of the Revenue and Taxation Code. When possible, such distribution shall be to an entity as herein qualified having similar purposes as this corporation. If this corporation holds any assets in trust, or the corporation is formed for charitable purposes, such assets shall be disposed of in such manner as may be directed by decree of the superior court of the county in which this corporation has its principal office, upon petition therefor by the Attorney General or by any person concerned in the liquidation, in a proceeding to which the Attorney General is a party. The purposes contained in this paragraph are limited to those meeting the requirements for a welfare exemption under Section 214 of the California Revenue and Taxation Code.
